## **INSPECTION NOTES**

On March 25, 2024, prevention officer L. Gibbins was notified on a report of an unsafe condition at this workplace. The officer spoke by phone, to two employer representatives (the employer) regarding the report of an unsafe condition.

Additionally, on March 26, 2024, the officer spoke by phone, to a third employer representative (the employer) regarding the report of an unsafe condition and next steps.

The Workers Compensation Act (the Act) and the Occupational Health and Safety Regulation (the Regulation) were used as a bases for compliance.

### I. UNSAFE CONDITION - Order #1

One of employer representatives stated that they were aware of the report of an unsafe condition on or about March 14, 2024; however, they did not take steps to investigate the condition. As such, order #1 is issued.

The employer stated that a scaffold system was erected by a team of this employer's workers for another team of workers to use to replace glass.

The following information was discussed in the phone meetings or provides the employer with additional information:

- the team who erected the scaffold system are qualified to do this task,
- workers who are to use the scaffold are instructed to inspect it prior to use; however, there may be a gap in knowledge on how to perform a pre use check as required in section 13.3 of the Regulation,
- the height to base ratio may not be 3:1 as required in section 13.17(4)(a) of the Regulation,
- there is a gap between the work platform and the structure wall that was reported to be between 18 to 29 inches as required in section 13.14(1)(b) of the Regulation, and
- a meeting took place on March 25 to initiate an investigation into the reported unsafe condition.

The employer is reminded that they must follow section 13.2(1)(a) of the Regulation that directs them to meet and use the applicable ANZI or CSA standard.

Additionally, the following are excerpts from Code of Practise for Access Scaffold CSA Z797-09 that the employer may find useful:

### 5.9.1 Free-standing or rolling scaffold

The height of a free-standing scaffold or a rolling scaffold shall not exceed three times the smallest lateral base dimension of the scaffold (this is referred to as the 3-to-1 stability ratio). Side brackets or other types of platform extensions shall not be. used on rolling scaffolds. Outrigger stabilizers may be used to increase the base dimension and allow a greater maximum height (see Figure 12). Where stabilizers have unequal extension, the lateral base dimension is twice the distance from the centreline of the scaffold to the centre of the least extended stabilizer /see Figure 1 3).

### 5.9.2.1 General

Where the height of a scaffold will exceed three times the smallest lateral base dimension, the scaffold shall be stabilized by

- (a) attachment to a building or structure by means of ties; or
- (b) attachment to the support surface by means of guy wires.

#### 5.12.1 General

Unless otherwise permitted by the authority having jurisdiction, guardrails shall be provided at all open sides and around any uncovered opening in a scaffold platform. A guardrail may be omitted at an edge of a scaffold platform where the width of the gap between a wall and the scaffold platform

A worker stated they reported the following unsafe condition to their supervisor (date: March 14, 2024); however, the supervisor did not investigate the following reported condition and ensure any necessary corrective actions were taken without delay: - lack of full platforms for worker to work on, - access to the platforms may present a fall hazard, - the scaffold was 40 feet and may require to be tied off, and - the height vs lateral base ratio may exceed 3:1.  The employer stated that the scaffold has been removed from service.
